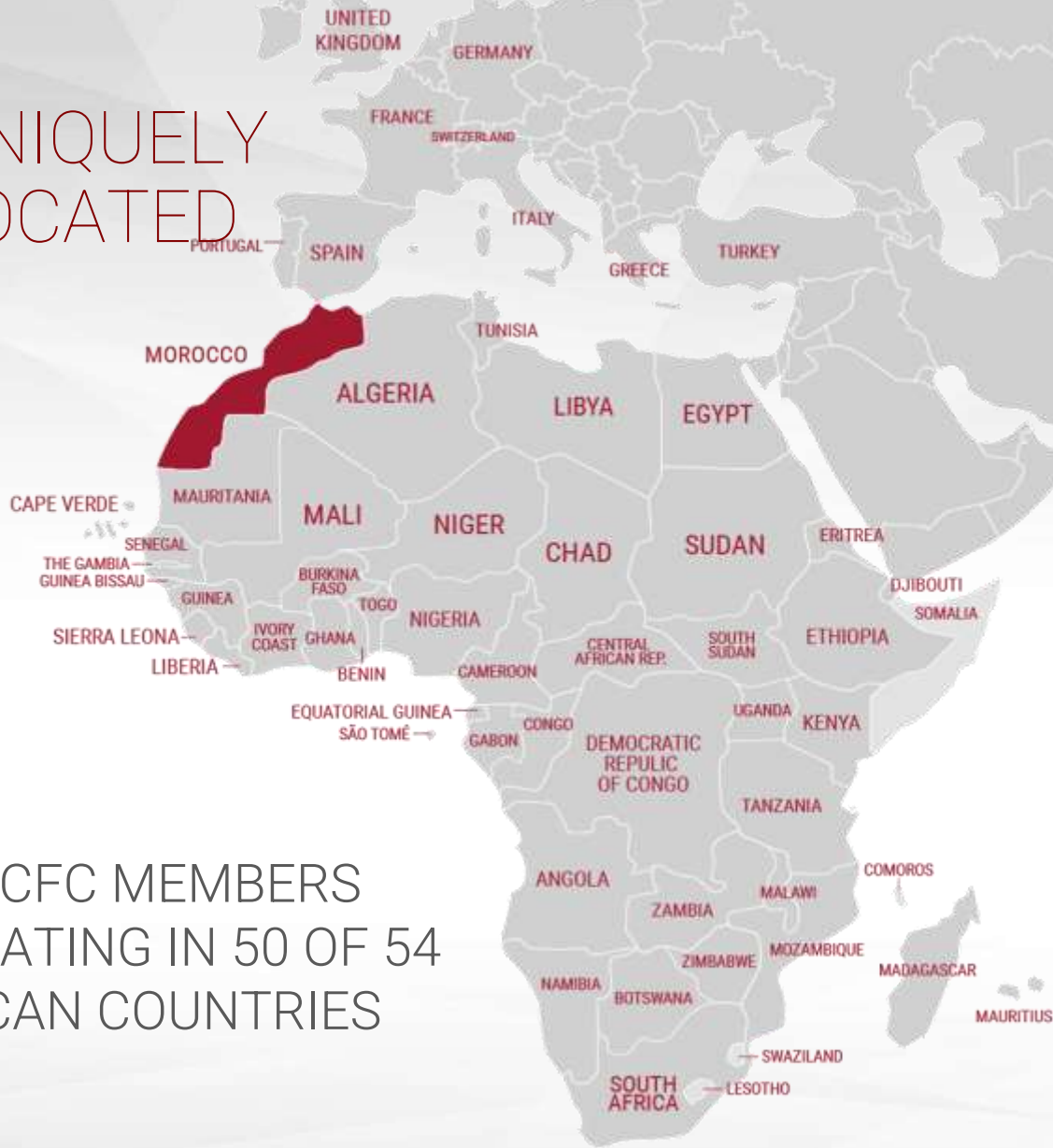

EDUCATION

Morocco's students must achieve proficiency in 2x foreign languages; French, Spanish or English. Scientific and technology subjects must be taught in foreign languages.

- ▶ 1 in 2 university students studies law, economics or social sciences, and 1 in 5 university students studies science, technology, engineering or mathematics.
- ▶ 8.5K scholarships have been granted by Morocco to non-Moroccan/African students.
- ▶ CFC has partnerships with CFA, CII and CISI to encourage the expansion of this talent pool.

- ▶ CFC first tower awarded LEED Gold certification by U.S. Green Building Council in 2019.

- Even before the recent normalization, economic exchanges have never ceased but on the contrary, have increased in the last years. No legally based boycott was applied in Morocco.
- Legal Pluralism in Morocco: The history of Morocco shows a divide between the rigid and enforceable nature of the French civil code and the traditional Amazigh informal justice system as well as Sharia law that focuses more on custom than strict adherence to text. Morocco knows how to have several segments of legal and judicial life coexisting together.
- The Family Code is also distinguished from this general practice of the civil code because it does not apply universally among Moroccans; Christian and Jewish citizens are not held to the same Islam-based law that applies to Muslim citizens. Morocco is the only country with rabbinic judges and tribunals dedicated to Jewish citizens family affairs.
- As a result, country legal system knows how to handle alterity and differences. Morocco has established civil, criminal, and commercial codes, as well as outlining procedure for such cases.

POINT 1: INVESTMENT PROMOTION AND TRADE

- To protect and promote the investment in Morocco, the legislator established a regime of convertibility for foreign investment to allow investors to freely carry out their investment business in Morocco and transfer directly to the banking system revenues generated by these investments.
- Financial intermediaries (such as banks) are authorised to transfer funds under control of supporting documents. Every foreign investor can hold a foreign currency account in a Moroccan bank. This account can only receive convertible foreign currencies. It can be used for: change operation, payments, transfers and withdrawals.

Investment Charter

- Investment incentives in Morocco have been provided by the Investment Charter (Law No. 18-95).
- Both foreign and local investors may benefit from grants and incentives provided under the Investment Charter.

Banking

The structure of the Moroccan banking system consists of a Central Bank (Bank Al Maghrib), commercial banks, offshore banks, micro-credit associations and financing associations.

POINT 2: AGENCY, DISTRIBUTION AND FRANCHISE

One option for businesses looking to start trading in Morocco is to appoint a commercial agent to sell the principal's goods and/or services. Agency and distribution often comprises one of three alternative types of arrangement:

- Agency
- Distribution
- Franchising

Under Moroccan law, there are no specific laws on either distribution or franchising. Commercial agency in Morocco is governed by Law No. 15-95, otherwise known as the Commercial Code.

POINT 3: LABOUR AND EMPLOYMENT

Employment law is regulated and governed by the Moroccan Labor Code passed by Dahir No. 1-03-194 (the Labour Code). There are three forms of employment contracts: definite term contracts, indefinite term contracts, and contracts to complete particular projects.

Rights of employees are guaranteed such as:

- Right to non-discrimination
- Right to equal pay between man and woman
- Right to health and safety
- Right to join unions
- Right to strike, etc.

Social security law

Morocco operates an obligatory social security system. Every employer must adhere to the national social security agency known as la Caisse Nationale de Sécurité Sociale (“CNSS”), and to register all employees and apprentices with this body.



POINT 4: LITIGATION AND DISPUTE RESOLUTION

Morocco has implemented modern laws regulating the courts and court procedure. National and international arbitration are recognized. Same for conventional mediation. Specialized courts also exist for tax matters, administrative matters or commercial matters. Foreign judgments or awards are also recognized.
