## PROVISIONS ON THE EXTENSION OF STAY PERMIT FOR FOREIGNERS HOLDING THE ITAS (LIMITED STAY PERMIT)/ITAP (PERMANENT STAY PERMIT) ABROAD

1. Background

In connection with the evaluation results of the Circular of the Director General of Immigration Number IMI-0661.GR.01.01 of 2021 dated March 26, 2021, regarding Visa and Stay Permit Requirements During the New Normal Adaptation Period and its affirmation, it is necessary to issue the Circular Letter of Director General of Immigration regarding Provisions on the Extension of Stay Permit for Foreigners Holding the ITAS/ITAP Abroad.

- 2. Objectives and Purposes
  - a. The purpose of this circular letter's issuance is to serve as a guideline for the implementation and evaluation of the Visa and Stay Permit policy during the New Normal Adaptation Period.
  - b. The purpose of the issuance of this circular is to serve as a guideline in optimizing the implementation of immigration duties and functions in implementing Visa and Stay Permit services during the New Normal Adaptation Period.
- 3. Scope

The scope of this circular letter shall be the affirmation of the provisions of extension of stay permit for ITAS/ITAP holder abroad in implementing services of Visas and Stay Permit in the New Normal Adaptation Period.

    - Conduct the supervision and control the implementation of the extension of the Immigration Stay Permit for Foreigners Holding the ITAS/ITAP abroad which will expire and is still abroad.

Provide the extension of the Foreigner's ITAS/ITAP and/or Multiple Re-entry Permit (*Izin Masuk Kembali* or IMK) to Foreigners who are still abroad whose stay permit will expire, through an application submitted by the sponsor/person in charge to the Immigration Office electronically or manually by fulfilling the following requirements:

- 1) The sponsor shall attach the photocopy of the passport;
- 2) Complete the application without going through the biometric collection process with the approval of the Director General of Immigration; and
- 3) Obligates the sponsor/person in charge to report the Foreigner's arrival to the Immigration Office no later than 30 (thirty) days since the arrival date in order to carry out calibration for the Foreigner's ITAS/ITAP and/or IMK.
- 6. Closing

This circular shall come into force from the date of establishment and will be further evaluated.

Therefore, this circular letter is issued for your kind attention and shall be implemented in its best endeavor. Thank you for your attention and cooperation.
