INTRODUCTION

The current U.S.-China trade war is spilling over to employment and labor issues. Disputes regarding employee-held trade secrets and non-competition restrictions are getting caught up in the bilateral tensions. Foreigners—including many Chinese nationals—are finding it harder to get legal authorization to work. Pressures are building in the U.S. to include labor standards in trade agreements. What is the current direction of employment law and policy in the U.S.? And how are multinational companies and Chinese investors adapting to changes from the Trump administration?

Stephen J. Hirschfeld, one of the leading employment lawyers from the United States, will provide us with insights and the latest developments on these matters, with a particular focus on California and Silicon Valley. He will be joined by JunHe employment group counsel Jeffrey Wilson to add views on the angle here in China.
